CANADA POST MAIL DELIVERY - CONVERSION TO COMMUNITY MAILBOXES

WHEREAS the Executive Committee of the City of Repentigny has adopted resolution no. CE-143-04-03-14 regarding Canada Post services;

WHEREAS Canada Post recently announced a significant change to its door-to-door mail delivery service that will initially consist in converting 11 Canadian communities,

including Repentigny, to community mailboxes starting in the fall of 2014;

WHEREAS municipalities have no say in this change to mail delivery in their jurisdictions, since Canada Post has full jurisdiction in this matter;

WHEREAS the municipalities do not agree with Canada Post's decision;

WHEREAS Canada Post will have to take special steps to accommodate those with restricted mobility;

WHEREAS municipalities have made it clear that the community mailboxes installed by Canada Post should be in keeping with existing urban planning frameworks in these municipalities.

THEREFORE, IT IS MOVED AND RESOLVED UNANIMOUSLY:

THAT the above preamble form an integral part of this resolution;

THAT the Council of the RCM of L'Assomption support the City of Repentigny as well as other municipalities, in their representations to Canada Post with respect to mail delivery;

THAT the Council of the RCM of L'Assomption recommend special steps be taken to meet the needs of individuals with restricted mobility;

THAT the Council of the RCM of L'Assomption also recommend that the community mailboxes installed by Canada Post be in keeping with the existing urban planning frameworks in these municipalities.
