**RESOLUTION NO. 14-02-45**

Item 9-9      **CANADA POST – CHANGES TO POSTAL SERVICE – SUPPORT**

WHEREAS Canada Post has announced that it intends to discontinue door-to-door mail delivery across the country within five years, starting in late 2014;

WHEREAS the Federation of Canadian Municipalities (FCM) is very concerned by how the increase in postal rates will impact rural and remote areas, as well as services provided to an aging population and Canadian homes who rely on door-to-door mail delivery;

WHEREAS the Federation of Canadian Municipalities will be meeting with Canada Post to discuss the ramifications of this announcement, and to ensure that the concerns of municipalities are considered during this process;

WHEREAS the Administrative Committee has made a recommendation by way of resolution CA 14-01-25, which was adopted at its regular meeting on January 28, 2014;

CONSEQUENTLY, on a motion by Councillor Denis Chabot, seconded by the Councillor Alain Jobin, BE IT RESOLVED

TO SUPPORT the Federation of Canadian Municipalities in its representations to Canada Post with a view to ensuring that the concerns of municipalities regarding door-to-door mail delivery are taken into consideration, and to send this resolution to the municipalities of the RCM for further support.
