Canadian Postal Service

Resolution #61-02-2014

WHEREAS, last December, Canada Post announced its plan to reorganize postal services;

WHEREAS, among the measures announced, Canada Post plans on eliminating door-to-door mail delivery in urban areas within the next five years;

WHEREAS these cuts will lead to the loss of 6,000 to 8,000 jobs;

WHEREAS Canada Post also announced a new rate structure, including for the purchase of stamps;

WHEREAS these steps will impact the most vulnerable, including senior citizens and the handicapped, who will have to make their way to community mailboxes to pick up their mail;

WHEREAS this decision will further isolate seniors and the handicapped, and no doubt affect their quality of life;

WHEREAS the increased price of stamps will make life even more expensive for families, small businesses and non-profit organizations on a daily basis;

WHEREAS City Council has serious concerns and questions about the effects of Canada Post's changes to postal service, notably with respect to the location and placement of community mailboxes within the city's jurisdiction.

WHEREAS the placement of new community mailboxes will have a considerable impact on our residential neighbourhoods (location, maintenance, snow removal, accessibility for the handicapped, etc.);

WHEREAS there are grounds for us to inform Canada Post that we disagree with the plans it has announced;

THEREFORE, it is moved by Ms. Nicole Chevalier, seconded by Ms. Suzanne Dauphin, and unanimously resolved:

- 1. That the above preamble be considered part of this resolution;
- That the Minister responsible for Canada Post be asked to take into
 consideration the concerns of cities and municipalities before implementing
 amendments to the Canadian Postal Service Charter, and to ensure that the
 public's and municipal authorities' point of view can be heard regarding the
 postal network and mail delivery service;
- 3. That a copy of this resolution be sent to Ms. Lisa Raitt, Minister of Transport; Mr. Denis Lemelin, National President of the Canadian Union of Postal Workers; Ms. Francine Raynault, MP; and Mr. Claude Dauphin, President of the Federation of Canadian Municipalities.
